1. Responsibility for your data:

2. Personal data we process:

Vows of Joy processes your personal data when you use our services and/or provide it to us. The following is an overview of the personal data we process:

Vows of Joy processes the following special and/or sensitive personal data from you:

- Sexual orientation (e.g., same-sex marriage)
- Religion (e.g., if a church ceremony is involved)
- Ethnic origin
- Health information (e.g., if it affects the performance of the agreement)

3. Purpose and legal basis for processing personal data:

- To perform the services as agreed upon, including contacting you if necessary for service delivery.
- To comply with legal obligations, such as maintaining records.

4. Sharing your personal data with third parties:

Vows of Joy does not sell your data to third parties and only discloses it when necessary for the execution of our agreement with you or to comply with a legal obligation. Your data is also stored in:

5. How long we retain your personal data:

6. Cookies or similar technologies used by Vows of Joy:

Vows of Joy uses cookies on its website solely for technical functionality, ensuring the website works properly, is optimized, and remembers your preferences.

7. Access, correction, or deletion of your data:

You have the right to access, correct, or delete your personal data. you can also withdraw your consent or object to the processing of your personal data by Vows of Joy. Additionally, you have the right to data portability. To exercise these rights, send a request to reeve@vowsofjoy.com. To ensure the request is legitimate, include a copy of your ID with sensitive information marked out. We will respond as soon as possible, but within four weeks, to your request.

8. How we secure personal data:

Vows of Joy takes the protection of your data seriously and implements appropriate measures to prevent misuse, loss, unauthorized access, unwanted disclosure, and unauthorized modification.
